1. The Executive Engineer , HIMUDA, Electrical Division Kasumpti, Shimla HP on behalf of Chairman HIMUDA Re-invites on lines bids on item rate in electronic tendering system, in Two Cover System for the under mentioned work from the eligible and approved Contractors / Firms /Companies registered with HPPWD/HIMUDA/HPSEBL/CPWD:-

2. **Availability of Bid document and mode of submission:** The Bid document is available online and bid should be submitted in online mode on website <https://hptenders.gov.in>. Bidder would be required to register in the web-site which is free of cost. For submission of bids, the bidder is required to have Digital Signature Certificates (DSC) from one of the authorized Certifying authorities (CA). Aspiring bidders who have not obtained the user ID and password for participating in e-tendering in HIMUDA may obtain the same from the website: <https://hptenders.gov.in> Digital Signature is mandatory to participate in the e-tendering. Bidders already possessing the digital signature issued from authorized CAs can use the same in this tender.

4. **TENDERS DETAILS :-**

The tender documents shall be uploaded on line in two covers:-

- 4.1. **Cover-I** i.e. shall contain scanned copies of all “ **Technical Documents/Eligibility Information**”
- 4.2. **Cover-2:** i.e. Shall contain “**BOQ/Financial Bid** ”where contractor will quote his Offer for each item.
- 4.3. **Cover-1 Technical Documents /Eligibility Criteria**” shall be opened first and the **Cover-2** i.e. financial bid of only those contractor shall be opened who fulfill the eligibility criteria and have uploaded the required documents in support of the same in **Cover-1(Scanned copies to be upload)** as detailed below:-
- i) Earnest money in the shape of NSC /Saving account in any of the Post Offices in Himachal Pradesh /Time Deposit Receipt of any Nationalized Bank, duly pledged in the name of **Executive Engineer , HIMUDA, ,Electrical Division , Kasumpti, Shimla-9** OR certificate of exemption of Earnest Money Deposit (**As per notification issued by HIMUDA**).
- ii) Cost of tender form in the shape of demand draft of **₹5000.00** only drawn in favour of **Executive Engineer, (E) HIMUDA,Electrical Division Kasumpti, Shimla-9** .
- iii) **Certificate of registration with HPPWD/ HPSEBL/CPWD in appropriate Class.**
- iv) **Other necessary document like Income Tax /Pan No./CGST/SGST/TIN No. registration of Firm/Company & EPF Nos.**
- v) **Detail of work done & work in hand as per proforma given under Condition No. 36.2(a) & (b) of HIMUDA for No. 6.**
- vi) **Bidding capacity as per under mentioned formula:
Bidders bidding capacity will be assessed by the given below formula :-**

Assessed available Bid capacity ($A \times N \times M - B$) where
A=maximum value of Electrical Engineering works executed in any one year during the last five years (Up dated to the price level of the financial year in which bids are received at the rate of 8 percent a year) taking into account the completed as well as works in progress.

N= Number of years prescribed for completion for completion of the works for which bids are invited period upto 6 months to be taken as half year and more than 6 months as one year).

M=2

B=Value , at the current price level, of ongoing works to be completed during the period of completion of the works for which bids are invited.

Note:- The statements showing the value of the existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed should be countersigned by the Engineer-In-Charge, not below the rank of an Executive Engineer or equivalent. Bid capacity duly assessed in the formula mentioned above should be certified by the registered /empanelled Chartered Accountant.

- 5: The intending Tenders shall have successfully executed (without Liquidated Damages or compensation)

Three similar works of 40% of the estimated cost put to tender.

Or

Two similar works of 50% of the estimated cost put to tender.

Or

One similar work of 80% of the estimated cost put to tender.

Rounded off to the nearest ₹ 10.00 Lacs in the last 7 years ending last day of the month previous to the one in which the tenders are invited.

- 6 **SUBMISSION OF ORIGINAL DOCUMENTS :** The bidder are required to submit (a) original demand draft towards the cost of bid documents and (b) original bid security/Earnest Money Deposit (EMD) and other Technical/Eligibility documents as mentioned under Sr. No. 4.3 (i) to Vi) to HIMUDA ,Electrical Division Shimla HP. as specified in Key dates, failing which the bids will be declared non-responsive.
7. **BID OPENING DETAILS :** The technical bid shall be opened on **06.09.2017 12.00 Hrs.** in the Office of **Executive Engineer (E) HIMUDA Electrical Division Kasumpti, Shimla-9** by the authorized officer. In their interest the tenderer are advised to be present alongwith original documents at the time of opening of tenders. If the Office happens to be closed on the date of opening of the bids will be opened on the next working day at the same time and venue.
8. The Bids for the work shall remain valid for acceptance for a period not less than **120 days** after the opening of financial Bid.

9. Other detail can be seen in the bidding documents (Form-6 & 8) . The officer inviting tender shall not be held liable for any delays due to system failure beyond his control. Even though the system will attempt to notify the bidders of any bid updates. The Employer shall not be liable for any information not received by the bidder. It is the Bidders responsibility to verify the website for the latest information related to the tender.
