The tender shall be received in my office on or before 2-01-2012 upto 11.00 A.M. and shall be opened on the same day at 12.30 P.M. in the presence of the Contractors/Firms or their authorized representative who wish to be present at the time of opening of tender.

TERMS AND CONDITIONS:

1. The tender documents shall be issued to only those Contractors/Firms:
 - (a) Who possesses valid HP Sale Tax Registration under H.P.State Sales Tax Act, 1968.
 - (b) The contractor will have to get himself registered with EPF Authority after the award of work and payment will only be released after the production of EPF registration, but not later than 3 months after award of work.
 - (c) The intending Contractor/ Firm shall give an under taking by way of affidavit clearly stipulating therein that he does not have more than two works in hand in the entire state of Himachal Pradesh dully attested and sworn before the Executive Magistrate or Notary Public.
 - (d) No tender form will be issued to contractor if he has two works in hand at the given time. Tender form will be issued to him only if one of the work is nearing completion i.e. at least 90% of the tendered amount have been executed by the contractor.
 - (e) 1% (One percent) Cess of construction will be deducted from the work done and contractor will get himself registered with the labour and employment department under Cess Act 1996.
 - (f) Tender will be issued to those who have not delayed the work more than 50% time of the contractual obligation for which he will have furnish suitable proof if he is not a working contractor of HIMUDA.
2. Draft Notice Inviting Tender/Drawings/specifications can be seen in the office of undersigned on any working day between 10.00 A.M. to 4.00 P.M.
3. Ambiguous/telegraphic/conditional tenders or tender by FAX/E-MAIL shall not be entertained/ considered in any case.
4. The Intending contractors/firms are requested to see the site of work before submitting the tender.
5. The earnest money in shape of cash/National Saving Certificate from any Post Office in HP/Time Deposit Account/F.D.R's of Nationalized Bank duly pledged in favour of Executive Engineer HIMUDA Division No.1 Kasumpti Shimla-9 shall be received alongwith the applications for obtaining tender forms. The application without earnest money will not be entertained and out rightly rejected.
6. The tender shall be issued on or before 30-12-11 upto 4.00 P.M.
7. The offer shall remain valid upto 120 days after opening of the tender.
8. If any of the date mentioned above happens to be local / gazetted holiday, the same shall be processed on next date.
9. Competent Authority reserves the right to reject/accept any or all tenders without assigning any reasons.
