 - (c) "The intending contractor/Firm shall give an undertaking by way of affidavit clearly stipulating therein that he does not have more than two works in hand in the entire state of Himachal Pradesh, out of which one of the work is nearly completion i.e at least 90% of tendered amount has been Executed by the contractor/Firm for which necessary certificate is required from the Competent Authority.
 - (d) Who possess valid PAN Number.
 - (e) 1% (one percent) Cess charges on the construction cost will be recovered from the contractor/firm and he/they will get registered with the Labour Officer-Cum-Registering Officer Cum Cess Collector Shimla under the building & other construction works(RD & CS)Act 1996 within one month from the issue of award letter.
 - (f) The tender will be issued to those who have not delayed the work more than 50% time of the contractual obligation.
